(IN 1861 OVER 900 MEN LEFT NEW YORK WITH THE 69TH, SO OVER A 1000 MEN MUST HAVE ENLISTED IN 1861, AS THERE WERE 215 DESERTERS. OTHER THAN THAT THERE WERE FEW DESERTIONS DURING THE HARD FIGHTING OF 1862 AND 1863. A HUGE NUMBER DESERTED THE 69TH IN 1864, BUT THIS I FEEL CAN BE REASONABLY EXPLAINED BY THE DRAFT, BOUNTY JUMPERS, AND THE TERRIBLE FIGHTING OF 1864, PARTICULARLY AT PETERSBURG, VIRGINIA.)

SUMMARY

We can never truly know why men deserted the 69th New York. Some must have had regrets about enlisting, so left; others later in the war probably only joined the regiment to receive the large bounties that were being offered. Others probably had a form of post-traumatic stress disorder, or shell shock after seeing horrific events happen in front of them; others feeling they had "Done their bit" probably felt justified in leaving after a period of time. But without having concrete evidence, in diaries and journals we will never know.
